Sri Balaji Vidyapeeth University, Puducherry - Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 06 seats in respect of students being trained at Mahatama Gandhi Medical College & Research Institute, Pondicherry.

I am to state that the General Body of this council at its meeting held on 22/11/2016considered the Compliance Verification Assessment Report (03/06/2016) along with the Council Assessor's report (April, 2014 for 2 to 3 seats and April, 2015 for 3 to 6 seats & 16/07/2015 for 2 to 3 seats) and compliance dated 31/03/2016 submitted by the college authorities on the standard of examination and other teaching facilities available at Mahatama Gandhi Medical College & Research Institute, Pondicherry for purpose of Recognition of MD(Anaesthesiology) qualification against increased intake from 02 to 06 seats granted by Sri Balaji Vidyapeeth University, Puducherry.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (03/06/2016) along with the Council Assessor's Report (April, 2014 for 2 to 3 seats and April, 2015 for 3 to 6 seats & 16/07/2015 for 2 to 3 seats) and compliance dated 31/03/2016 submitted by the college authorities and decided to recommend to the Central Government that MD(Anaesthesiology) qualification against increased intake from 02 to 06 seats granted by Sri Balaji Vidyapeeth University, Puducherry in respect of students being trained at Mahatama Gandhi Medical College & Research Institute, Pondicherry be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.".
